



COVID-19 Visitation Update

Here at MSCC of Morton, we strive to keep our residents and their families connected. With all the requirements and regulatory changes that are being made daily by the governing bodies, it is hard to keep up. We are currently offering outdoor visits, by appointment only. Appointments are available Monday-Friday from 1:30-3:30. We are going to start offering Saturday visits with appointments being from 12:00-4:00. These are 15-minute sessions for you to visit with your loved ones. These visits are monitored by staff to ensure all safety precautions are followed. If at any time our facility has an outbreak all visitation will be cancelled immediately. Masks are required to participate in the outdoor visit. As always, we are still allowing window visits. If the window to the resident's room is raised, the resident and the visitor are required to wear a mask. September Right of the Month:

Transfer and Discharge

A resident and his or her representative are entitled to thirty days advance notice of transfer or discharge and the reasons for it. However,

transfer or discharge may be on shorter notice when the health or safety of the resident is endangered, the resident's health improves enough to allow for a more immediate discharge, immediate transfer or discharge is needed due to urgent medical needs or the resident has not resided in the facility for a period of at least thirty days.
